Use this form to apply for an exemption for pre-1990 forest land that has tree weed species on it, or had tree weed species cleared from it on or after 1 January 2008.

To apply for this exemption:

- the land cannot already have been made exempt for another reason (such as being less than 50 hectares)
- you must be the landowner, or a third party who holds the right to deforest the land and the landowner has no control over the decision
- the tree weed species must be a pest in a pest management plan under the Biosecurity Act 1993 or listed in the Schedule 5 of the Climate Change (Forestry) Regulations 2022 (available at www.legislation.govt.nz/regulation/public/2022/0266/latest/LMS709974.html)

When you submit this application you must include:

- a digital map (known as a shapefile) that meets the Geospatial Mapping Information Standard (available at www.mpi.govt.nz/mapping-forest-land-ets/)
- · a copy of the certificate of title, Māori Land Court record, or other document that proves who owns the land.

Exemption time period

If an exemption is granted, you can deforest the land without notifying Te Uru Rākau – New Zealand Forest Service and paying New Zealand Units (NZUs or units). If you do not start clearing the tree weeds on your land within five years of receiving the exemption, Te Uru Rākau – New Zealand Forest Service may declare that your land ceases to be exempt land.

If an exemption is removed, the pre-1990 forest land is no longer exempt. If you deforest any more of the land afterwards, you need to submit an emissions return and pay units. However, you may apply for a new exemption after the previous one is removed.
