- 6. The collection of this information is authorised by the Freshwater Fish Farming Regulations 1983. The provision of this information is voluntary, however all sections of this form must be completed before an application for the registration of an aquaculture lease/licence can be processed.
- 7. It is an offence under Section 231 of the Fisheries Act 1996 to supply false or misleading information.
