## 1 Purpose

- (1) This information document has been issued to accompany the OMAR *Goats for breeding or fattening to the Argentine Republic*, dated 31 May 2017. This information document should be read in conjunction with that OMAR.
- (2) The MPI Animal Exports team are aware of issues with these particular Overseas Market Access Requirements (OMAR). Significant changes relate to the removal of certain measures and exports may be possible while a revised export certificate is being negotiated.

# **GOAANI.AR-ES 31 May 2017 – Goats for breeding or fattening to Argentine Republic**

### 1. Statutory authority

Pursuant to section 60, section 60A, section 62(1) and section 167 of the Animal Products Act 1999 I notify the following:

- (i) the issue under section 60 of the export requirements for Goats for breeding or fattening to Argentine Republic GOAANI.AR-ES dated 31 May 2017;
- (ii) the determination under section 62(1) of the format and content of the official assurance for Goats for breeding or fattening to Argentine Republic GOAANI.AR-ES dated 31 May 2017.

This notice takes effect from 31 May 2017.

#### 2. Argentine Republic requirements

Goats for breeding or fattening exported from New Zealand to Argentine Republic must be accompanied by an official assurance in the form of a completed zoosanitary certificate.

The zoosanitary certificate as specified below must be completed and certified, after due enquiry, by an Official Veterinarian of the Ministry for Primary Industries.

#### **Explanatory note:**

If the zoosanitary certificate is not certified then the goats for breeding or fattening do not satisfy the conditions in the notice. Likewise, if the goats for breeding or fattening do not satisfy the zoosanitary requirements in the certificate, then the certificate will not be certified
