Dairy Products: Powdered Milk and Milk Products - Change of Use from Human to Animal Consumption

CTO direction for Synergy Nutrition Ltd as to equivalent measures in powdered milk products imported under an import health standard for human consumption, then diverted for animal consumption.

Pursuant to section 27(1)(d)(iii) of the Biosecurity Act 1993 I, Vicki Melville, Manager Animal Imports, Ministry for Primary Industries (under delegated authority), give the following directions for powdered milk products from Australia, Canada, EU, Japan, and/or the USA imported under the following import health standards:

- Import Health Standard for the Importation of Dairy Products and Products Containing Dairy Ingredients from Australia (DAIEDIIC.AUS; 1 August 2006)
- Import Health Standard for Milk and Milk Products for Human Consumption from the European Union and Swiss Confederation (DAIEDIIC.EEC; 19 July 2010)
- Import Health Standard for the Importation of Dairy Products and Products Containing Dairy Ingredients from Specified Countries (DAIEDIIC.SPE; 1 September 2011).

Powdered milk products for human consumption imported under the import health standards listed above may be diverted to animal feed, as the following import health standards **not** for human consumption from these countries have comparable requirements:

- Import Health Standard for the Importation into New Zealand of Dairy Products Not for Human Consumption from Australia (FODDAIIC.AUS; 17 July 2001)
- Import Health Standard for the Importation of Dairy Products Not for Human Consumption into New Zealand from Canada and the USA (FODDAllC.NAM; 17 July 2001)
- Import Health Standard for Heat Treated Milk and Milk Products Not for Human Consumption from the European Union (DAIFODIC.EU; 28 June 2012)
- Import Health Standard for the Importation of Dairy Products Not for Human Consumption into New Zealand from Specified Countries (FODDAIIC.ALL; 17 July 2001)
- Import Health Standard for the Importation into New Zealand of Dairy Products Not for Human Consumption from Japan (FODDAIIC.JAP; 16 May 2001)

Dairy Products: Powdered Milk and Milk Products - Change of Use from Human to Animal Consumption

This is justifiable given: 1) the treatment requirements of the import health standards for human consumption are equal to or exceed the requirements in the import health standards not for human consumption listed above; 2) these countries are free of Foot and Mouth Disease; and 3) the processing of powdered milk products far surpasses the minimum requirements in these standards and in the draft Import Risk Analysis for Milk and Milk Products for any end-use.

The reason for this direction is that the biosecurity risks associated with this commodity have been assessed and are managed effectively.

This direction takes effect from the date of signing and continues in effect until amended or revoked.
