Further to our meeting on Monday 8<sup>th</sup> March 2004 I would like to out line a proposal with regard to providing your department with monthly intelligence updates on Anti GE and Animal Rights issues.

TCIL would like to provide you with national intelligence about these two key topics so as to enable you to keep abreast of current trends. This information will be readily available to MAF and will prove invaluable should an incident occur.

We provide this service to private industry and would not see this as being a conflict of interest to MAF. The cost of this service is much greater than what one organisation can afford. With a contribution from each client TCIL can provide a great service for a reduced amount. The intelligence is obtained by various methods and is plotted on the I2 chart system that MAF are used to.

The cost to MAF for this intelligence gathering and collating service can be offered to you at § 9(2) plus GST per month. This figure is less than what we are currently charging industry. TCIL would require a 12 month commitment from MAF as costs are incurred when various methods of intelligence gathering are implemented.

There may be occasions when MAF may wish to task TCIL to conduct further investigations in to a specific GE or animal rights issue. We recognise that this sort of request would be of great importance and of the most sensitive nature to MAF. This type of work would be done separately from private industry and the information obtained would be for disclosure to MAF only. Further more any information provided by MAF would be owned by MAF and would not be disclosed to any other organisation by TCIL. The cost for investigation and other services would be offered to MAF at our usual rate of deployment.

TCIL have enjoyed working on the PAM and AGM projects and believe that we have proven our integrity when dealing with sensitive information.
