Introduction

This introduction is not part of the Animal Products Notice, but is intended to indicate its general effect.

Purpose

The purpose of this notice is to notify the sampling regimes for animal material and animal products for the Ministry for Primary Industries (MPI) National Chemical Residues Programme.

Background

The National Chemical Residues Programme is established under the Animal Products Act 1999 for official monitoring, surveillance and surveys of animal material and products. The primary objectives are:

- to provide confidence to domestic consumers and export markets about the quality, safety, and integrity of New Zealand animal products in relation to dietary exposure, residue, and contaminant standards; and
- b) to confirm whether the MPI system for the control of residues and contaminants is working as designed.

The National Chemical Residue Programme commenced in 1999 and is operated under the Animal Products (Regulated Control Scheme – Contaminant Monitoring and Surveillance) Regulations 2004. Samples are collected from randomly selected and targeted healthy live and slaughtered animals. The samples are tested for a wide range of residues and contaminants at recognised laboratories contracted to MPI for the provision of testing services.

The results of the National Chemical Residues Programme are used to verify that animal products produced for human consumption comply with New Zealand and importing country residues and contaminants requirements.

Who should read this Animal Products Notice?

You should read this notice if you are:

- a) supplying mammals, fish or birds for primary processing intended for human consumption;
- b) supplying wild animals, including wild mammals, game estate animals and farmed mammals that have become feral and then been killed, for processing intended for human consumption;
- c) an animal product officer;
- d) an official assessor;
- e) an observer appointed under section 223 of the Fisheries Act 1996;
- f) acting under the direction of an animal product officer; or
- g) a competent person within the meaning of the Animal Products (Regulated Control Scheme Contaminant Monitoring and Surveillance) Regulations 2004.

Why is this important?

The National Chemical Residue Programme is required to provide confidence to domestic consumers and for the provision of official assurances for export animal products included in this notice. For the purposes of section 135(1)(c) of the Animal Products Act 1999, a failure to comply with this notice, without reasonable excuse, is an offence.

Part 1: Requirements

1.1 Application

- (1) This notice applies to:
 - a) animal product officers;
 - b) official assessors;
 - c) observers appointed under section 223 of the Fisheries Act 1996;
 - d) persons authorised by the Director-General for the purposes of taking samples for monitoring, surveillance or survey programmes specified in Parts 1, 2, 3, 4 or 5 of Schedule 1 of the Regulations; and
 - e) competent persons within the meaning of regulation 6(1) of the Regulations.

1.2 Definitions

(1) In this notice, unless the context otherwise requires:

Regulations mean the Animal Products (Regulated Control Scheme – Contaminant Monitoring and Surveillance) Regulations 2004.

(2) All terms or expressions that are defined in the Animal Products Act 1999 or regulations made under that Act and used, but not defined, in this notice, have the same meaning as in that Act or those regulations.

1.3 Sampling regime

(1) The sampling regime specified in Schedule 1 to this notice applies from 1 July 2021 to 30 June 2022.

1.4 Competent persons

- (1) All animal product officers are competent persons for the purpose of taking samples for monitoring, surveillance or survey programmes specified in Parts 1, 2, 3, 4 or 5 of Schedule 1 of the Regulations.
- (2) All official assessors are competent persons for the purposes of taking samples from a class of animal material or animal product for monitoring, surveillance or survey programmes specified in Parts 2, 3, 4 or 5 of Schedule 1 of the Regulations.
- (3) All observers, appointed under section 223 of the Fisheries Act 1996, are competent persons for the purposes of taking samples from a class of animal material or animal product for monitoring, surveillance or survey programmes specified in Part 5 of Schedule 1 of the Regulations.
