1. Statutory authority

Pursuant to section 60, section 60A, section 62(1) and section 167 of the Animal Products Act 1999 I notify the following:

- (i) the issue under section 60 of the overseas market access requirements for dogs and cats to Ethiopia DOMANIEC.ET dated 15 May 2015;
- (ii) the determination under section 62(1) of the format and content of the official assurance for dogs and cats to Ethiopia.

This notice takes effect from 15 May 2015.

2. Ethiopia requirements

Dogs and cats exported from New Zealand to Ethiopia must be accompanied by an Official Assurance in the form of a completed zoosanitary certificate.

The zoosanitary certificate as specified below must be completed and certified, after due enquiry, by an Official Veterinarian of the Ministry for Primary Industries.

Explanatory note:

If the zoosanitary certificate is not certified then the dogs and cats do not satisfy the conditions in the notice. Likewise, if the dogs and cats do not satisfy the zoosanitary requirements in the certificate, then the certificate will not be certified.

- 2. The export certificate is valid for ten (10) days after being issued.

Section 61A of the Animal Products Act 1999 states that 'The Crown is not liable, and nor is the Director-General or any employee of the Ministry liable, for any loss arising through the refusal or failure of the relevant authority of an overseas market to admit export animal material or animal product to that market'.
